#### Fraud and Foreign Nationals By Doug Pollack

The continuing incidents of fraudsters stealing the identity of owners of vacant lots and real property in Florida seem to have no end in sight. In many cases, the real owner is a foreign national living outside the United States and the fraudsters provide images of foreign passports and other identification that cannot be verified.

The simple truth is there is no website or service available to verify if the foreign identification being presented is authentic and belongs to the real seller. They use fake email addresses, proxy servers, foreign bank accounts and internet telephone numbers making it extremely difficult to be sure you are dealing with the real owner of the property.

The following are some simple suggestions to help you determine whether you are dealing with the proper individuals and have been presented with valid government identification:

1. Call the owner of record if you can establish a telephone number through independent sources and/or send a letter to the owner's address as listed on the property appraiser's website to inquire if they have listed their property for sale and have accepted an offer to sell.

2. Verify through public records the property has not been conveyed without reasonable consideration or by Quit Claim Deed in the last six months.

a. In the case of forged Quit Claim Deeds, they are usually prepared, executed and recorded shortly before the Contract for Sale & Purchase has been executed.

Fraud and Foreign Nationals	b. Check to make sure the notary public is real and if necessary, contact the Notary to make sure they are qualified and knowledgeable about real estate documents and that they notarized the deed in question.
2021 Forms Update	Require high quality color images of all identification presented so the holograms and other security features can be observed. a. When a foreign passport is presented along with either a national identification card and/or foreign driver's license, you can utilize the <u>"PRADO" website</u> to find current examples of passports and other government identification for members of the European Union and other participating countries in Latin America and North America. b. Importantly, understand you will NOT be able to positively verify any foreign passport without confirming
FLC Celebrity Conference 2022	<ul> <li>through the country of issue. Instead consider requiring copies of their US documentation as that can be more easily verified. More importantly, you need to require good quality color images of all identification presented.</li> <li>3. For property held by a foreign nationals, it is possible to verify their travel and passport information from 2016 forward quickly and without cost through a US government website operated by the US Customs &amp; Immigration Service (USCIS) <a href="https://i94.cbp.dhs.gov/194/#/history-search">https://i94.cbp.dhs.gov/194/#/history-search</a>. If there travel history is inconsistent with the facts</li> </ul>
Carolyn Monroe's Holiday Letter	<ul> <li>and circumstances of their acquisition or management of the property, this is a big red flag.</li> <li>a. If the passport number they provide does not show up in the database, that passport has never been used for entry to or exit from the US since inception in 2016 or the passport may be fraudulent, and you need to exercise more caution.</li> <li>b. If their travel was prior to 2016, you will want to make sure you ask for copies of the immigration stamps for the last entry and exit from the United States.</li> </ul>
	4. For those individuals that purport to be permanent residents of the US and present a copy of the Alien Registration Card (green card) for identification, keep in mind that they are required to live full time in the United States with the intention of immigrating and gaining citizenship. If a "green card holder" has been out of the US for more than six months, efforts to immigrate are considered abandoned, their "green card" is cancelled, and thus is no longer a valid form of identification

5. Always request two forms of identification. We have found it is very unlikely that fraudster will go to the trouble of making more than one or two counterfeit identity documents.

If you still have suspicions after completing due diligence, DO NOT CLOSE UNTIL YOU ARE SATISFIED ALL IS IN ORDER. Consider requiring the seller to appear in person for closing at a location you select prior to disbursing seller's proceeds.
